

EQUITY SCHOLARSHIPS INFORMATION FOR 2019

AFTRS BACHELOR OF ARTS SCREEN: PRODUCTION

Purpose

AFTRS Equity Scholarships are awarded to assist financially disadvantaged Bachelor of Arts Screen: Production students with the costs associated with higher education.

The scholarships are intended to support people from low socio-economic backgrounds or who are otherwise under-represented in higher education to study at AFTRS. Up to 30 AFTRS Equity Scholarships may be offered for BA Screen students. Ten per cohort will be offered in 2019.

Payments

AFTRS Equity Scholarship funds are provided by *The Kenneth Myer Fellowship Trust*. Each scholarship is valued at \$5,000 and is for one year only.

\$2,500 will be awarded each semester, to be paid following the applicable census date. Payments are conditional on the recipient remaining enrolled, in good academic standing, and continuing to meet the eligibility and disadvantage criteria, and any other conditions.

Assessment of applications

There are limited funds for scholarships, so AFTRS may not be able to support everyone who applies or who demonstrates they are in need.

AFTRS will determine which, if any, applicants will be awarded a scholarship. AFTRS' decision is final and no correspondence about decisions will be entered into. An applicant cannot receive two scholarships for the same year.

Successful applicants will be told of any conditions of a scholarship.

In 2019 the recipient of the equity scholarship cannot defer the commencement of the scholarship.

Who can apply?

To be eligible to apply, you must:

1. Complete an application submission for the Bachelor of Arts Screen: Production
2. Be enrolled in the Bachelor of Arts Screen: Production; and
3. Be an Australian citizen or Australian permanent resident or a New Zealand citizen; and
4. Be financially disadvantaged, as described in this Information Sheet.

Supporting documents must be submitted to AFTRS by the closing date.

You will be notified by email whether or not your application is successful by the above date.

How to apply

1. Demonstrating disadvantage

You must demonstrate financial disadvantage. Ways of doing so include:

- **For Australian citizens and residents:** through receiving a means-tested Commonwealth income support payment (such as Parenting Payment Single, Disability Support Pension, Carers Allowance, Newstart, Austudy, ABSTUDY, Youth Allowance). You will be asked to provide your Centrelink number when applying; or
- **For New Zealand citizens or other people not receiving a means-tested Commonwealth income support payment:** by other information demonstrating exceptional, real and enduring financial hardship. If you do not receive a Commonwealth income support payment you should complete the Financial Hardship form and provide documentation such as bank statements and other financial documents that demonstrate your need.
- **You may demonstrate other educational disadvantage, such as one or more of the following:** carer responsibilities; sole parent responsibilities; long-term medical condition/ disability or ongoing effects of abuse; English language difficulty; Australian Aboriginal or Torres Strait Islander; visa holder under Australia's humanitarian visa program; or regional or remote disadvantage. You should provide documents that attest to your disadvantage in the relevant area.

2. Certification of documents provided

Any documents you provide as support material must be certified copies. AFTRS' certification requirements are available at <https://www.aftrs.edu.au/students/future-students/how-to-apply/>

3. Translation of documents provided

If supporting documents are not in English, you are required to supply certified copies of the following:

- the document in the original language; and
- an English translation of the document by an accredited translator. Do not send original supporting documents.

4. Subsequent applications

If you are unsuccessful in 2019, you may re-apply for any AFTRS' Equity Scholarships in the future. You would then need to meet all scholarship eligibility and disadvantage criteria at that time.

If you are successful you may also reapply for an AFTRS Equity Scholarship in subsequent years, so long as you meet the eligibility and disadvantage criteria at that time.

A new application, with new supporting documents, would need to be submitted.
