

2026 SENATE ORDER FOR ENTITY CONTRACTS LISTING RELATING TO THE PERIOD FY2025-26 (1 July 2025 – 30 June 2026)

Pursuant to the Senate Order for entity contracts, the following table sets out contracts entered into by the Australian Film, Television and Radio School (AFTRS) which provide for a consideration to the value of \$100,000 or more (GST inclusive) and which:

- a. have not been fully performed as at 30 June 2026, and/or
- b. which have been entered into during the 12 months prior to 30 June 2026.

No contracts have been excluded due to confidentiality reasons.

Where listed, the contracts contain general confidentiality provisions that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

The reasons for including such clauses include:

- a. ordinary commercial prudence that requires protection of trade secrets, proprietary information, and the like; and/or
- b. protection of other Commonwealth material and personal information.

The accountable authority of AFTRS provides assurance that the listed contracts do not contain any inappropriate confidentiality provisions.
